1.1 - NDS® composite panel (steel & aluminium)

Consists of:

- 2 outer layers of steel (0.6 mm, 1 mm, 1.5 mm or 2 mm) or aluminium (1 mm, 2 mm or 3 mm)
- a 50 μm thick viscoelastic layer (density 954 kg/m₃)

1.2 - MDT-ALU® multi-layer damping tile

Consists of (from exposed side):

- a 1 mm thick aluminium sheet
- a 0.25 mm thick visco-elastic adhesive (density 1600 kg/m3)
- $\ a \ 2.5 \ mm \ thick \ self-adhesive \ high-density \ polymer-based \ non-combustible \ heavy \ layer \ (density \ 2010 \ kg/m3)$

Tested laid on a 4 mm thick aluminium substrate, also covering MDT-STEEL®.

1.3 - MDT-STEEL® multi-layer damping tile

Consists of (from exposed side):

- a 0.5 mm thick steel sheet

4. APPLICATION / LIMITATION:

- 4.1 For **NDS® composite panel:**
- 4.1.1 Approved material is considered as having low flame spread characteristics (as per IMO 2010 FTP Code Part 5) and not producing excessive smoke and toxic products (as per IMO 2010 FTP Code Part 2).
- 4.1.2 **Restricted application:** use is restricted to floor coverings or primary deck coverings only.
- 4.2 For MDT-ALU® / MDT-STEEL®:
- 4.2.1 Approved material is considered as having low flame spread characteristics (as per IMO 2010 FTP Code Part 5).
- 4.2.2 In application of FTP Code 2010 Annex 2 § 2.2, the product is expected to satisfy the requirement of smoke & toxicity of IMO 2010 FTP Code Part 2 without further testing.

- 4.2.3 In application of FTP Code 2010 Annex 2 § 2.3, the product is expected to satisfy the requirement of maximum gross calorific value (e.g. 45 MJ/m²) without further testing as per ISO 1716.
- 4.2.4 Acceptable only for use on any metallic substrate having a thickness of at least 3 mm.
